

District-wide Organizational Maturity Scores

Organizational Maturity Scores for the individual organizations in the district are provided in the table below. Each score is based on calculations used to determine status levels and will increase as the organization improves accessibility maturity. The target scores equate to fully “Established” maturity across all milestones.

Institution Overview

- Rural location
- Single college district with two campus locations: Weed & Yreka
- Primary transfer institution = Southern Oregon University
- 2023-2024 FTES = 1581.67 (A 41.9% increase compared to 2022-2023)
- One of 14 CCCs with on-campus housing



Pre-ACMM

Issue: Noncompliance with ADA 508 - Use of non accessible, third party content

Solution: Third party content banned from use

Action: Comprehensive Civil Rights Compliance On-Site

Review of College of the Siskiyous, conducted on June 13 – 17, 2022.

Outcome: Corrective Action Plan with 97 non compliant items. All have been addressed and corrected.



During ACMM

- Campus-Wide Virtual Kickoff: March 22, 2024
- In-Person, [1.5 days Training](#): April 15 and April 16, 2024
- [Siskiyous Baseline Report](#) = 61.6 points (out of a possible 356)



After ACMM

- Identification of ACMM Governance Group
- Initial Governance Group Meeting to identify 24-25 action items: July 17, 2024

24-25 Action Items:

- Creating a technology procurement request form which requires submittal of associated ACR (VPAT)
- Creating a local definition of technology and requirement to submit technology procurement request form process. Share college-wide.
- Convert current student and employee evaluation Survey Monkey into an MS Form.
- Add WebAIM training link to faculty orientation Canvas shell as well as New Employee Onboarding


