 - Report of student contact info sent directly from CCCTC

Parent Question, AB2881

- Added to online CCPG & standard application (Y/N)
- Same text and options in both applications
 - Do you have a child or children under the age of 18 who will receive more than half their support from you?
- Determined through collaboration with CCCCO
 Financial Aid and Research offices



Nonresident Tuition Form

- Updated Nonresident Tuition
 Form for AB540
- Available to students as a link upon application submission

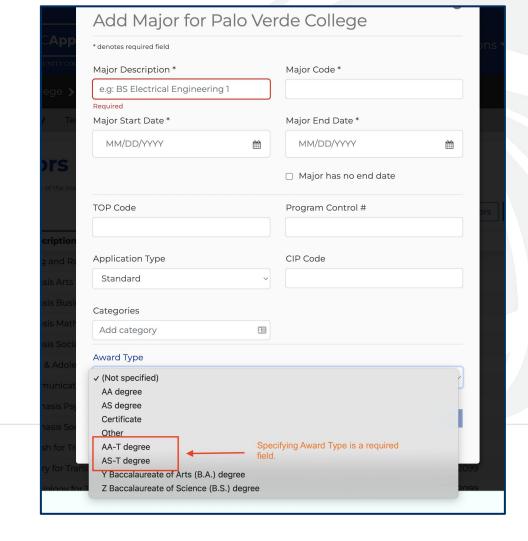
Legislative Changes in the Works

AB928, Student Transfer Reform Act

- Filter Majors by Award Type
 - Guide students to majors that fit their Ed Goal
 - One 4-year transfer option for Ed Goal?
